RICS NI MATRICS CHAIR'S INTRODUCTION: Mark Johnston MRICS

2022 seen the resurgence of Matrics in Northern Ireland with several professional and social events and schools and university visits. Our launch event was held in Zen restaurant Belfast and was a business lunch, we had around 16 young surveyors in attendance and went well. This was followed by an RICS NI Matrics day at the Races in June, where we attended the Down Royal Annual Summer Festival. This was the largest event to date with c. 50 young professionals in attendance with support from 4 major sponsors. We have also held 2 CPD webinars towards the end of the year with our 'Back to basics' series which included topics on GDPR and accounts, this seen an audience c. 60 on each webinar with surveyors from across the UK and Northern Ireland joining online.

On Friday 10th of February RIC SNI Matrics had its first event of 2023 a 'Scavenger Hunt' around Belfast, this saw, c.60 young professionals get together in teams of 2-4 from across Belfast to go around the city following the clues led out for them and ended with Pizza, drinks, and networking. We held a raffle in aid of our RICS NI Charity of the Year Air Ambulance Northern Ireland and we raised over £250 with some fantastic raffle prizes donated.



We have more to come in 2023, it will see us back to Down Royal for the Summer festival on June 23rd and lots more networking/social gatherings for our young professionals. We also plan to host an APC "Mock-Mock" where we will have a run a live mock APC final interview assessment, candidates can attend and ask questions after watching the interview.

Our next CPD event is on the 9th of March online and will have Matthew Morris FRICS who is a Land Steward for the Dutchy of Cornwall, he will give an insight into his day-to-day role as a rural surveyor, and you can book to attend on our online academy (OLA).





Overview

Spring 2022 saw the movement from regulation to guidance of COVID restrictions in which RICS began to engage in person with the membership throughout Northern Ireland. In May, Market Engagement Lead, Lisa O'Connor came in to post with a view to strengthen the market in Northern Ireland through interacting with RICS NI members and having open and honest conversation on how to deal with the sector specific challenges facing the region. RICS NI Consultation Roadshows



This autumn RICS NI hosted three consultation roadshow events across Northern Ireland and invited our members along to give their feedback and engage with board and staff members, the areas we went to where Armagh, Belfast, and Derry~Londonderry. 

A LOOK BACK ON 2022: GOVERNMENT ENGAGEMENT AND ADVOCACY


Overview

The public affairs team plays a key role within RICS to protect the interest of members and ensure the profession continues to exert influence over the sector, and the wider economy. It sets out to:

- Shape built environment policy in the public interest and in the interest of RICS members.
- Establish RICS as the go-to organisation for expertise on built environment matters among policy makers.
- Build understanding and awareness of the profession and promote RICS members with key stakeholders.

In addition to these broad policy objectives, a key element of the role in Northern Ireland specifically has been to re-establish a strong RICS presence among policymakers and their officials, and to rebuild a strong, mutually beneficial relationship with members across Northern Ireland.

A snapshot of the core policy areas RICS is engaged with in Northern Ireland can be found below.



Highlights

Supporting government and market stakeholders in decarbonisation

The RICS Sustainability Suite of standards, which comprises the International Cost Management Standard (3rd Edition), Whole Life Carbon Assessment and Built Environment Carbon Database have been promoted to government departments, health trusts, education providers, housing associations and other organisations interested in decarbonisation. RICS has organised roundtable discussions with government and market



stakeholders to develop awareness of the challenges of decarbonisation as well as the opportunities and RICS is delighted to have secured the adoption of these standards in delivering non-domestic public buildings and domestic properties.

High Street Regeneration

RICS engaged with the Department of Finance to encourage landlords and tenants to work together and resolve any disputes over rent payments, and RICS members contributed market insight into the recent revaluation exercise undertaken on non-domestic properties in Northern Ireland.

Cladding and Fire Safety

Over the past year RICS has worked closely with officials delivering the Building Safety Programme NI which is reviewing building safety in Northern Ireland in response to Dame Hackitt's Interim and Final Report for Secretary of State for Housing, Communities and Local Government. RICS is contributing technical expertise and insight and is informing the recommendations which will be made in the final report.

Delivering better buildings for people

Queen's University Belfast, the Education Authority, and a range of other organisations in Northern Ireland are working with RICS on trialling the International Building Operation Standard (IBOS) and the forthcoming new self-assessment tool. The standard has been promoted at several roundtable discussions and directly with estate managers across the public sector.

Housing Leadership

RICS engaged with officials developing the draft Housing Supply Strategy and subsequently contributed to the formation of the strategy by providing member expertise and market insight. RICS called for a specific outcome which relates to housing in the Programme for Government as a mechanism to bring focus and drive momentum to the issue of housing supply. RICS also noted that current procurement strategies did not make the most of professional services and led to a race to the bottom in quality.

RICS addressed the Law Society of Northern Ireland's Annual Conveyancing Conference 2022 to communicate the role of the chartered building surveyor in dealing with the purchase, lease, and disposal of residential property. RICS is currently working with the Law Society and NAEA on an update to the voluntary memorandum of understanding designed to clarify roles between surveyors, solicitors, and agents.

Calls to Action for Stormont to level up communities across the UK

Ahead of last year's regional elections, RICS published eight <u>calls to action</u> (which can be found at rics.org under News & Insights) for public authorities to level up and transform communities across the UK, including a specific manifesto for Northern Ireland. It includes



recognising the role of investment and professional stewardship and embedding net zero and social value at the heart of decision making.

RICS has promoted member insight to the Belfast Chamber of Commerce who are exploring city centre revitalisation. The Chamber have engaged with RICS and are keen to collaborate more closely on issues relating to high street regeneration and commercial development. We also promoted RICS' <u>Commercial Real Estate Impact Report</u> among partner organisations and policy makers, emphasising its role in revitalising our towns and city centres.

Land Reform & Rural

RICS is engaged across government departments on land matters including DEFRA in relation to land management, natural capital and the rural economy, DfT regarding compulsory purchase of land and BEIS and DCMS on the expansion of the communications infrastructure and the implications of land use for both landlords and tenants. Closer to home, RICS is working with DfI Rivers Agency on issues relating to flooding and HED on better understanding the carbon picture of their heritage buildings.

Supporting a housing market which works for Northern Ireland

RICS regularly engages with other professional bodies to contribute member insight and technical expertise into matters relating to the housing market. RICS contributed a member judge for the Chartered Institute of Housing Awards 2022 and meets CIH regularly to share insight and collaborate on areas of mutual interest. RICS and the Northern Ireland Federation of Housing Associations worked closely together to build housing associations awareness of the decarbonisation challenge and the need for retrofitting of domestic properties to improve energy efficiency and reduce emissions.

Skills & DEI

In March, RICS in Northern Ireland was delighted to deliver a member-led event which coincided with International Women's Day and Women's History Month. The event considered entry into the profession, career progression and the challenges and opportunities of more flexible working. The panel was chaired by Sharon McClements and comprised senior figures from academia, private practice, and the public sector to give greater prominence to female surveyors and the audience included chartered surveyors and students on accredited courses.

<u>Adoptions</u>

A core objective of the Public Affairs team is to secure the adoption of RICS standards, policies and thought leadership by key decision makers in our global markets. Such adoptions demonstrate trust, recognition, and awareness of RICS leadership, while offering solutions to government and market priorities, and securing future demand for the profession.

Over the past year, RICS has worked alongside policy makers in Northern Ireland to integrate key standards and thought leadership. Such standards include:



Sustainability Suite, made up of the Whole Life Carbon Assessment, International Cost Management Standard 3 (ICMS3), and the Built Environment Carbon Database. We have worked in collaboration with government departments to embed sustainability and RICS standards into their guidance do delivering net zero non-domestic public buildings. RICS has also engaged with housing providers to help them deliver more sustainable domestic property for their current and future tenants. The Education Authority is sharing data on embodied carbon as they establish a baseline for their schools and broader estate.

International Building Operations Standard

Queen's University Belfast, the Education Authority, and the NI Courts and Tribunal Service are working with RICS on adopting the <u>International Building Operation Standard (IBOS)</u> and the new RICS self-assessment tool into their building performance and measurement approaches.

RICS Public Sector Asset Management Guidance Note is promoted as part of the Strategic Investment Board's advice to public sector clients on asset management.

Other: In addition to the flagship standards above, we were delighted to work with the Head of the NI Civil Service to promote the profession and its expertise in issues relating primarily to building safety and carbon measurement, but also in other areas too. The meeting with the Head of the NI Civil Service has been helpful in showcasing the work our members do across Northern Ireland and led to RICS being appointed to the Expert Panel for the Building Safety Programme (NI).

Be a Northern Ireland Counsellor


