How does RICS assure the quality of the Panel?



Introduction to security of payment legislation, the process of Adjudication

Certificate in Adjudication

Adjudication, enshrined within security of payment legislation, allows for the quick ruling on disputed payment claims, allowing cash to flow down through the hierarchy of construction contracts.

Our training enables course participants to acquire a detailed understanding of the adjudication process under the security of payment legislation and to obtain a certificate in adjudication, which is one of the required steps for appointment as an adjudicator to the RICS DRS panel of adjudicators.
