

Register of RICS Accredited Mediators on the President's Panel

RICS Dispute Resolution Service maintains a register of RICS Accredited Mediators and RICS Accredited Evaluative Mediators who are on the President's Panel of Mediators. This means that they have satisfied the criteria for inclusion on the President's Panel, passed the panel assessment interview and are therefore eligible to receive appointment/nominations as mediators when such requests are received by RICS.

The names appearing on this register are mediators who have successfully completed:

- RICS Accredited Mediation training and assessment, and
- The assessment interview for President's Panel of Mediators

The register also includes names of RICS Accredited Evaluative Mediators. RICS Accredited Evaluative Mediators can use their expertise to guide the parties. For example, they can provide neutral evaluation, if considered appropriate, as to the prospects of success in court or arbitration based on the evidence revealed to the mediator and help the parties to achieve an outcome based on wider commercial as well as narrow legal grounds. If parties are looking for an Evaluative Mediator, they are advised to make enquiries directly with the mediator and ask them to confirm whether they undertook the RICS Evaluative Training and are able to provide neutral evaluation if required.
