RICS Whole Life Carbon Assessment

Measuring the environmental impact of our infrastructure has become increasingly crucial. The WLCA Standard was first introduced in 2017, for consistent and accurate carbon measurement in the built environment. Its objective, to guarantee that the data we collect on carbon emissions is consistent, accurate, and comparable across different projects and asset classes. The 2nd Edition WLCA, which came into effect in July 2024, builds upon the previous standard, extended to cover all buildings and infrastructure throughout the built environment life cycle.
