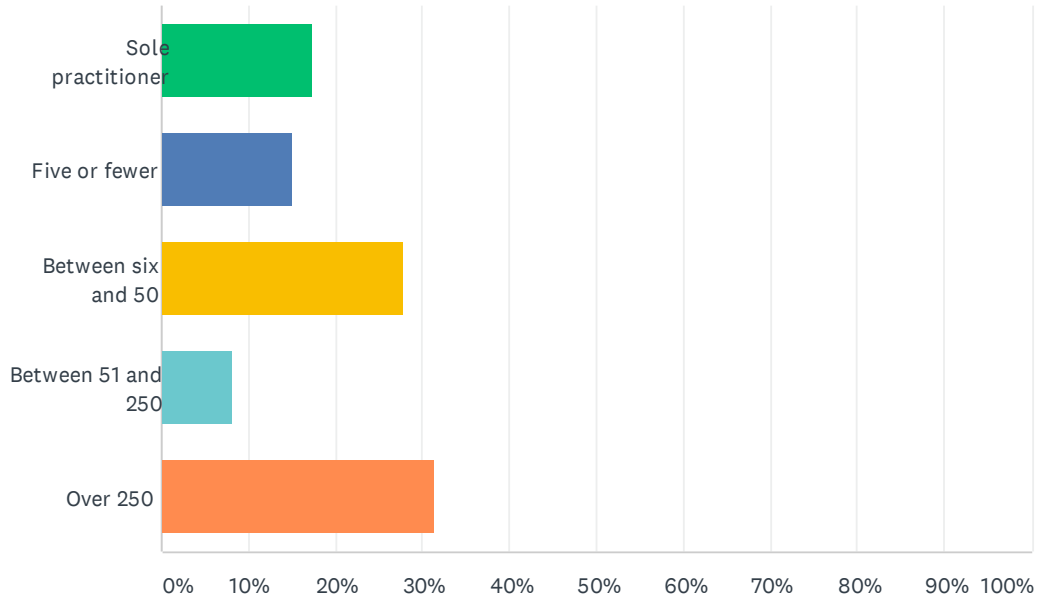

Q2 How many people does the business you work for employ?

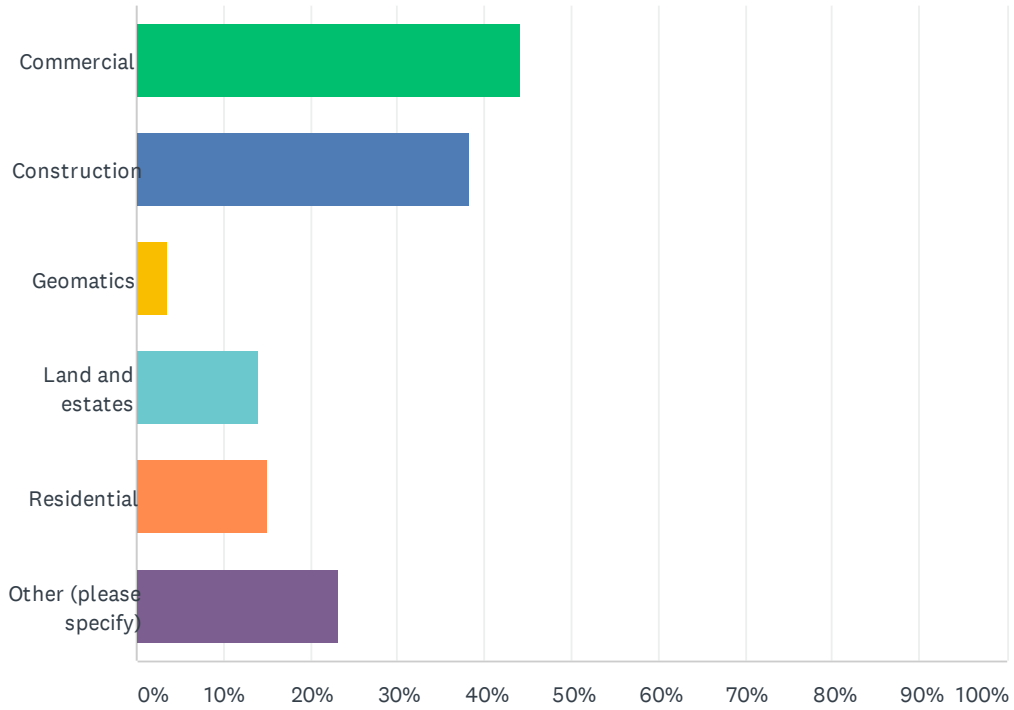

Q3 What sector do you work in?

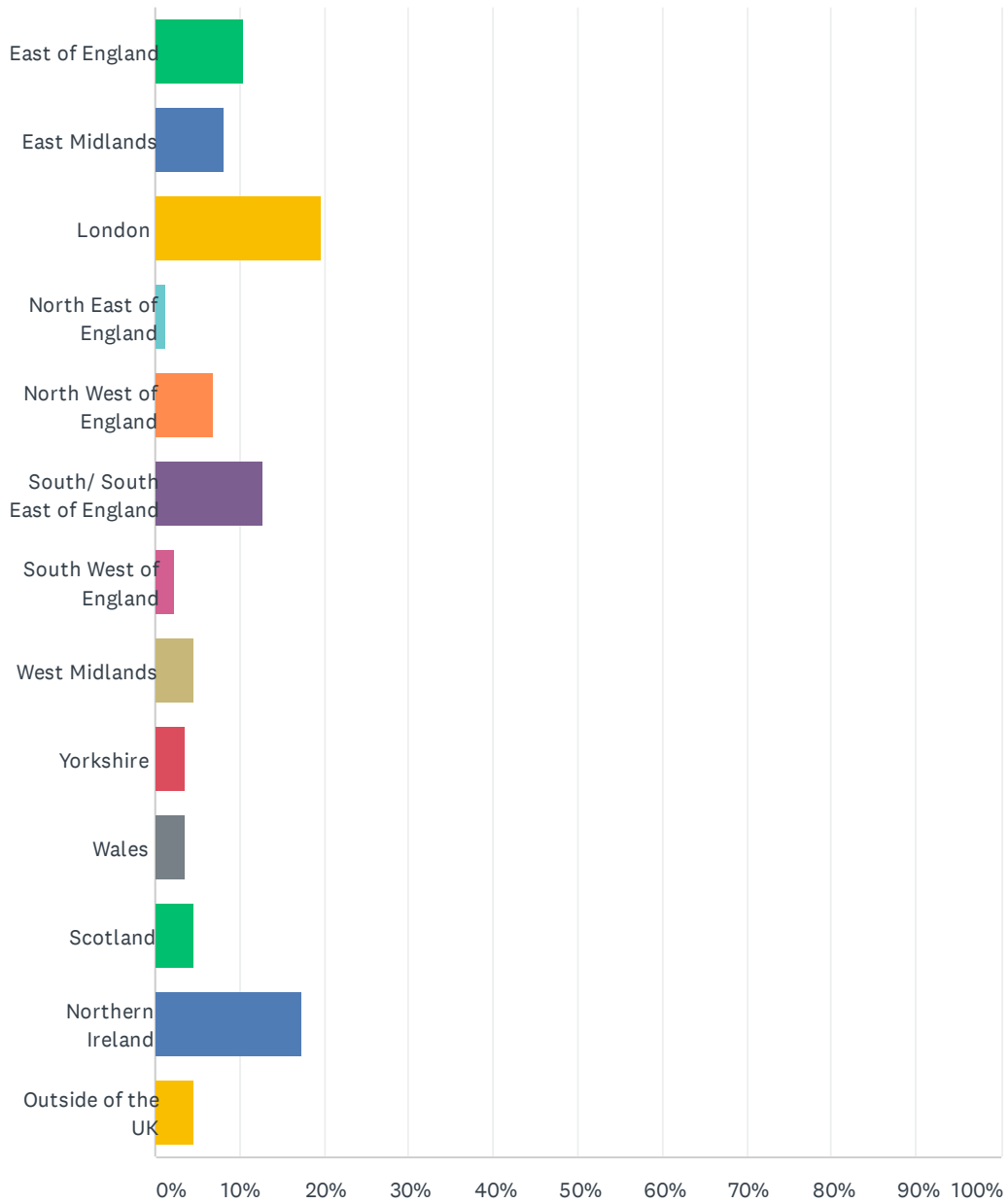

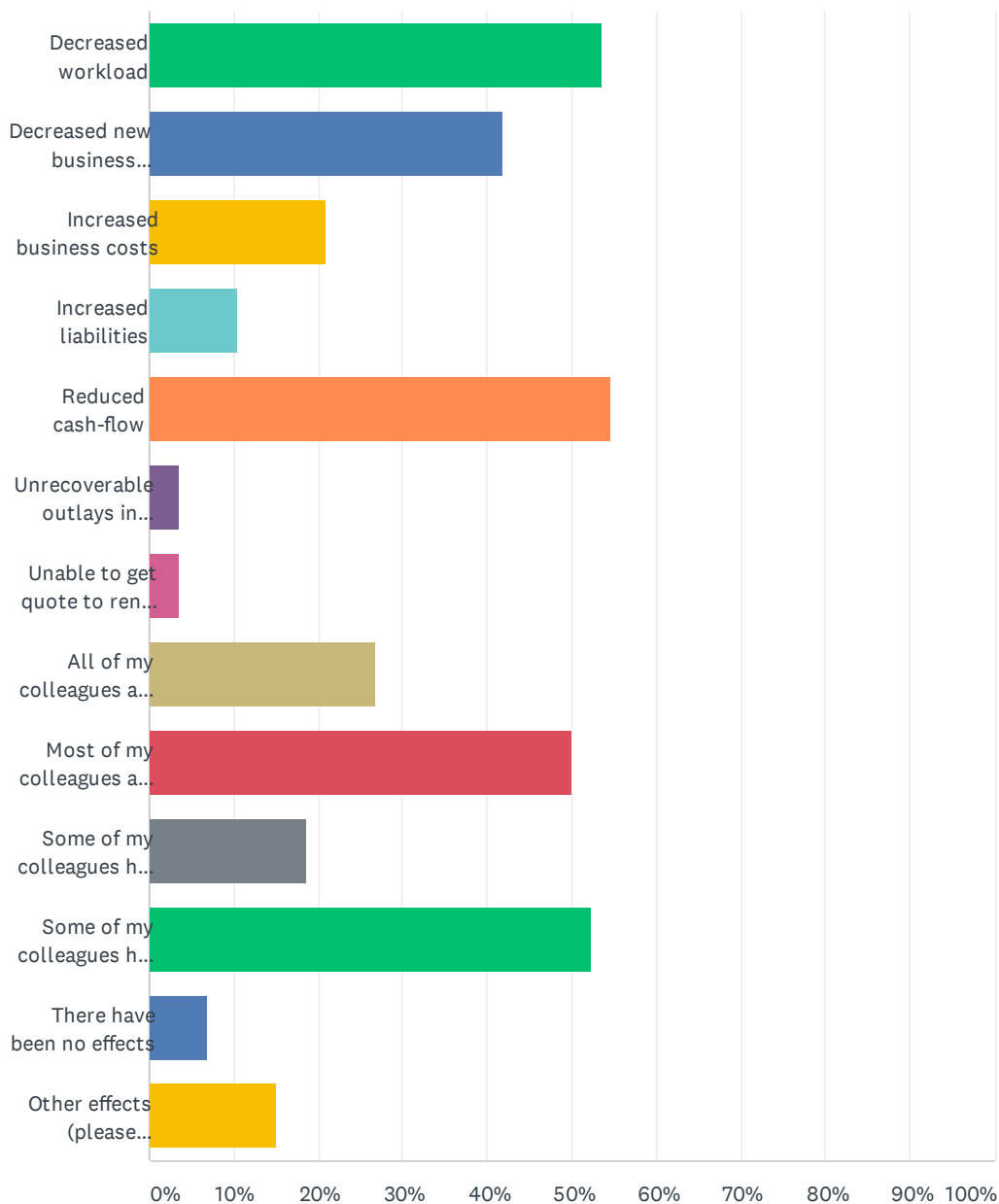

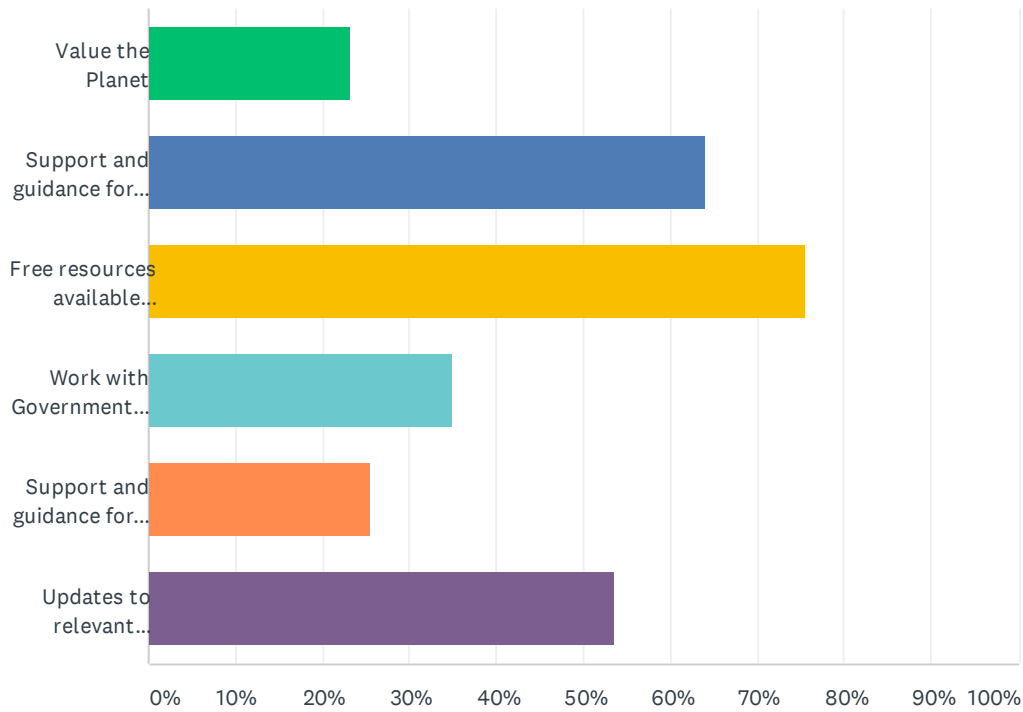

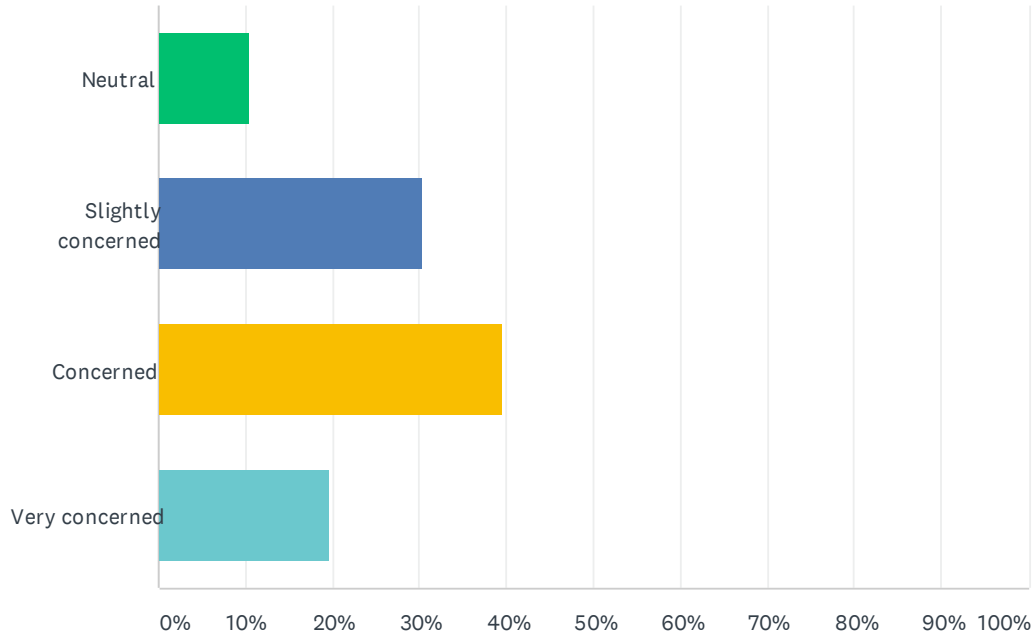

Q7 At this time, how concerned are you about the impact of Coronavirus/COVID-19 on your business?

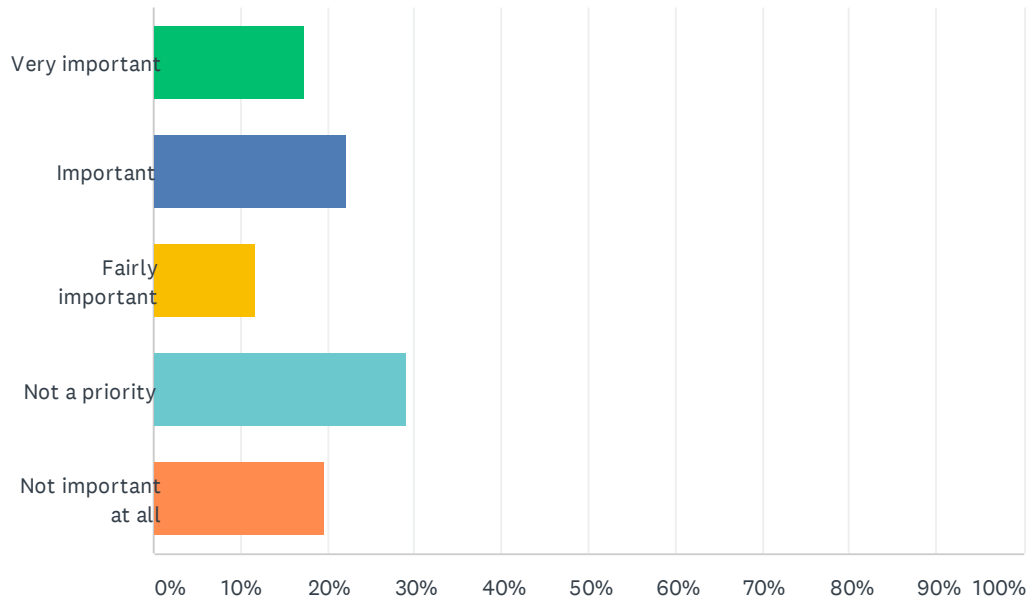

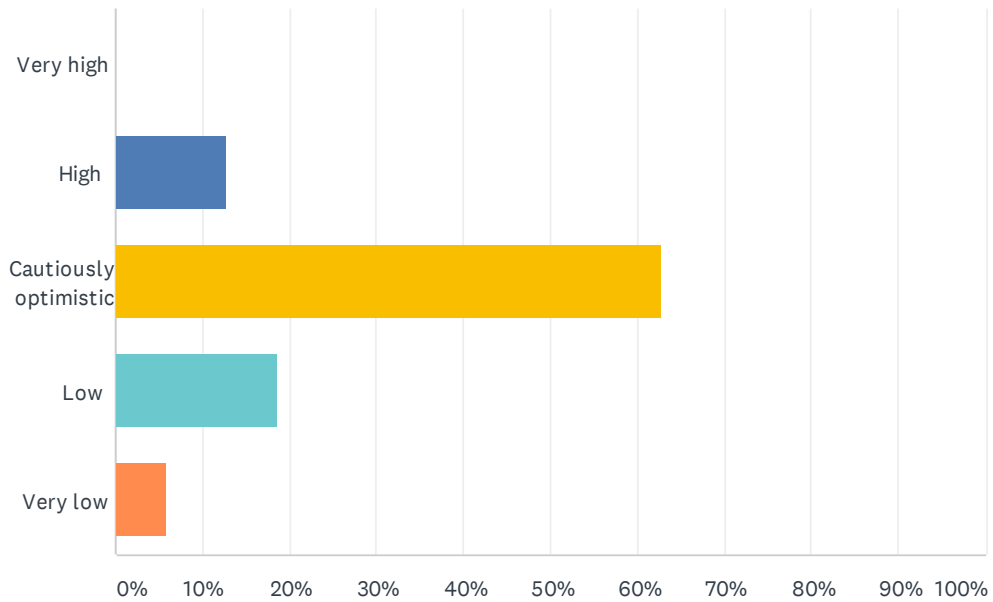

Q9 What is your level of confidence for the next 12-24 months? Please specify

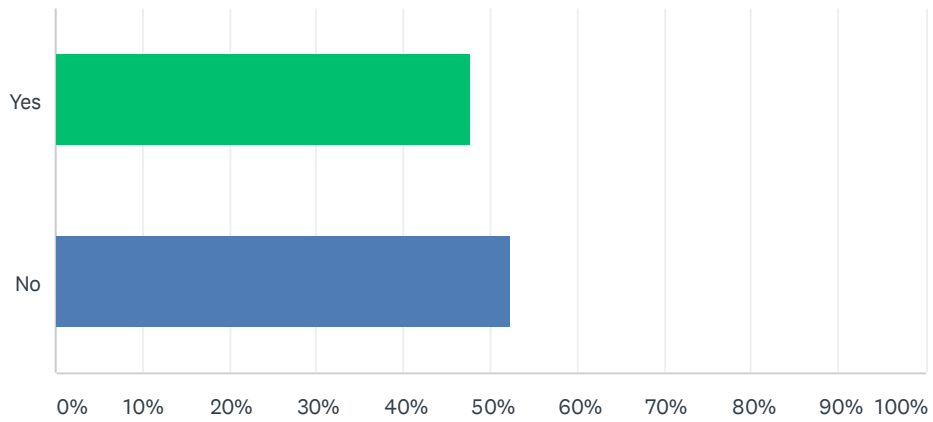
